Law's donation ranks fourth on philanthropy list.

Houston oil heiress Caroline Wiess Law's name appears for the first time on the Chronicle of Philanthropy and Slate magazine's annual census of the nation's biggest donors, entering the list at the No. 4 with a \$450 million bequest to Houston's Museum of Fine Arts, Baylor College of Medicine and the University of Texas M.D. Anderson Cancer Center.
